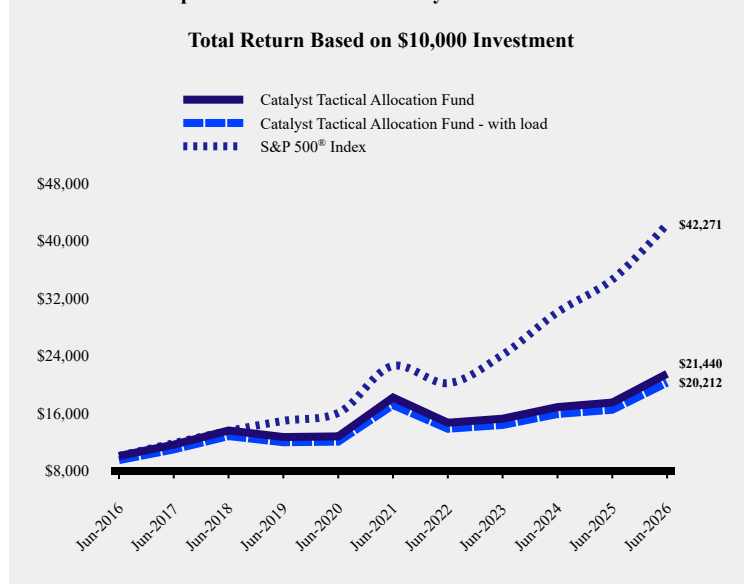

How did the Fund perform during the reporting period?

Fund performance for the fiscal year ended June 30, 2026, was largely shaped by continued equity market strength, with the Fund's risk model maintaining a positive signal throughout most of the period. This supported a full equity allocation, consistent with the strategy's systematic approach to trend and volatility. As in prior years, this positioning generally led to greater upside participation during rising markets and reduced exposure during pullbacks.

Equity markets posted strong gains, led by a narrow group of AI and AI-adjacent stocks in the Technology and Industrials sectors; the Fund's equity portfolio, which is typically characterized by high active share and conviction-based positioning, maintained exposure to these sectors, which allowed the Fund to participate in the rally's strongest segments. The Fund's positive performance during the fiscal year was primarily driven by overweight positioning within the Technology and Industrials sectors.

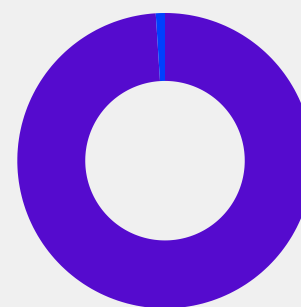

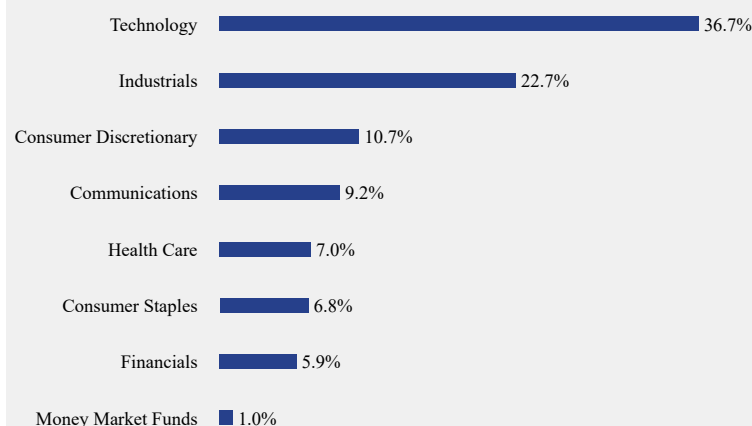
Asset Weighting (% of total investments)
